

# Blue Sky Media - WEDDING CONTRACT

**DEPOSITS & FINAL PAYMENT:** Ceremony OR Reception Only: \$400.00; Recession Buster: \$700; Blue Sky Prod.: \$1000. Dates will be held open until deposit is received. Deposits are non-refundable. For all productions, the balance is due one week before the event.

**PHOTO MONTAGE OPTION:** Montage is limited to 35 photos. Additional photos are \$5.00 each. Blue Sky Media cannot be held responsible for photos damaged or lost in the mail. All Photos must be received by the wedding date. *Composition of pictures will vary from TV to TV depending on model and your settings.*

**MUSIC FOR PHOTO/HIGHLIGHT MONTAGE & LOVE STORY OPTIONS:** If possible, please provide your track(s) in the form of Original Label CD. All music tracks must be received by the wedding date.

**FOR ALL PRODUCTIONS:** Standard Definition Productions (as opposed to HD Productions) will be shot using a standard 4:3 aspect ratio. If you want 16:9 (widescreen), there is no extra charge but you must specify below. Also, we need additional music for various reasons during post-production. There's a helpful paper called "Sound Tracks" on the pricing page of my site. We encourage you to pick from this list or submit your own music. If you do not, you are leaving the song selection to us. Also, any additions or changes in regard to the description in the brochure, demo, or website which take the form of format, style, content, structure, composition, etc. must be finalized with BSM before the day of the event. Standard Coverage is seven hours.

**COMPLETION:** Once all necessary materials (photos, music etc.) have been received, and balance has been paid, editing typically requires 4-6 weeks depending on size of package and season.

If 6 months after the wedding, all materials (photos, music etc.) have still not been received, Blue Sky Media will no longer be obligated to edit the respective Montage(s)/Options and the video will be finished without them.

**MISC:** Blue Sky Media will need to receive a map to all locations. Blue Sky Media retains copyright to the finished video. Blue Sky Media grants Client use of video to view and/or copy, for personal use, without limitation. Another words, you can make all the copies you want, but images recorded can't be sold or used by any person or entity for the sake of any demo, broadcast, or exhibition w/o the written permission of Blue Sky Media. Unless objection is raised, Blue Sky Media reserves the right to use reproductions of your video for promotion.
